


N.B; Please read the Instructions:

1. After expiry of the Last Date with double fee, forms will be accepted with a fine of Rs. 500/- for every spell of 15 days with maximum of Rs. 2000/- till three weeks prior to the commencement of Examination
2. Examination forms & fee submitted only through the following Bank Branch will be acceptable:
 - a. NBP University of Malakand Campus Branch only in A/C No. **1-4**
3. Forms duly filled in, accompanied by the required documents and complete in all respect shall be submitted in the above-mentioned Bank
4. Forms through post office or any other courier service shall not be accepted
5. All candidates must attach attested copies of B.A/B.Sc Degree/certificate, three 4x4 size latest coloured photographs, CNIC/Domicile Certificate, Original Migration Certificate of the concerned University in case, registered with a University other than University of Malakand
6. Pharm- D Compart students are required to submit separate forms for each year
7. Examination forms of Regular & compart students shall be submitted through the HODs concerned
8. Incomplete forms shall not be entertained in any case
9. Last date means the last date on which the forms, complete in all respect accompanied by the relevant documents & fee receipt must be submitted to any one of the above stated Bank
